Procedure:

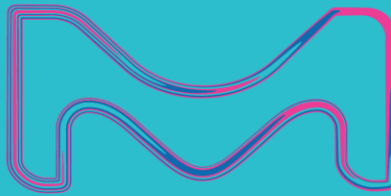
